3 must be nominated using the nonpartisan process established in Title 13, chapter 14, for primary elections and
4 be elected with a partisan designation as provided in [section 1].

5 (b) An incumbent justice who is the only candidate for the office must be placed on the general
6 ballot as provided in Article VII, section 8, of the Montana constitution and 13-14-212."

8 **Section 3.** Section 3-5-201, MCA, is amended to read:

9 **"3-5-201. ~~Election~~ Nomination, election, and oath of office.** (1) The judges of the district court,
10 except judges pro tempore, must be elected by the qualified voters of the district.

11 (2) (a) Except as provided in subsection (2)(a), judges of the district court must be nominated
12 using the nonpartisan process established in Title 13, chapter 14, for primary elections and be elected with a
13 partisan designation as provided in [section 1].

14 (b) An incumbent judge who is the only candidate for the office must be placed on the general
15 election ballot as provided in Article VII, section 8, of the Montana constitution and 13-14-212.

16 (2) Except as provided in subsection (1), each judge of a district court shall, as soon as the judge
17 has taken and subscribed the official oath, file the official oath in the office of the secretary of state."

19 **Section 4.** Section 3-10-201, MCA, is amended to read:

20 **"3-10-201. ~~Election~~ Nomination and election.** (1) Except as provided in 3-10-206, each justice of the
21 peace must be elected by the qualified electors of the county at the general state election immediately
22 preceding the expiration of the term of office of the justice of the peace's predecessor.

23 (2) A justice of the peace must be nominated and elected ~~on the nonpartisan judicial ballot~~ in the
24 same manner as judges of the district court.

25 (3) Each judicial office must be a separate and independent office for election purposes, each
26 office must be numbered by the county commissioners, and each candidate for justice of the peace shall
27 specify the number of the office for which the candidate seeks to be elected. A candidate may not file for more
28 than one office.

1 (4) Section 13-35-231, prohibiting political party contributions to judicial officers in primary
2 elections, applies to justices of the peace."

4 **Section 5.** Section 13-10-602, MCA, is amended to read:

5 **"13-10-602. Use of party name.** (1) Except as provided in [section 1] and subsection (3) of this
6 section, a political party and its regularly nominated candidates, members, and officers have the sole and
7 exclusive right to the use of the party name. A candidate for office may not use any word of the name of any
8 other political party or organization other than that by which the candidate is nominated in a manner that
9 indicates or implies the individual is a candidate of the nonnominating party.

10 (2) An independent or nonpartisan candidate, except as provided in [section 1] and subsection (3)
11 of this section, may not use any word of the name of any existing political party or organization in the candidacy
12 in a manner that indicates or implies that the individual is a candidate of that party or organization.

13 (3) A candidate for an elective office under an elected county official government provided for in 7-
14 3-111 who is running in an election conducted after electors have approved a change pursuant to 7-3-103(4) in
15 the type of election held from partisan to nonpartisan may use a party name or symbol in the candidate's
16 campaign material."

18 **Section 6.** Section 13-12-203, MCA, is amended to read:

19 **"13-12-203. Appearance of candidate's name and party designation on ballot.** (1) (a) Subject to
20 13-12-202 and except as provided in 13-10-209 for nonpartisan offices, and 13-10-303 for certain other
21 candidates, and subsection (1)(b) of this section for candidates for judicial offices, in partisan elections,
22 candidates' names must appear under the title of the office sought, with the name of the party in not more than
23 three words appearing opposite or below the name.

24 (b) the name of a candidate for judicial office must appear under the title of the office sought, with
25 the name of the candidate's political party designation provided pursuant to [section 1] in not more than three
26 words appearing opposite or below the name.

27 (2) Subject to 13-12-202, in nonpartisan general elections, the candidates' names must appear
28 under the title of the office sought, with no description or designation appearing with the name unless partisan

1 and nonpartisan offices appear on the same ballot. In such a case, the names of nonpartisan candidates must
2 appear with the word "Nonpartisan".

3 (3) Except as otherwise provided by this section, information about the candidate other than the
4 candidate's name may not appear on the ballot, including a title, accomplishment, award, or degree."

6 **Section 7.** Section 13-14-212, MCA, is amended to read:

7 **"13-14-212. Form of ballot on retention of certain incumbent judicial officers.** (1) If the
8 incumbent is the only candidate for the office of chief justice, supreme court justice, district court judge, or
9 justice of the peace, the election administrator may not include a ~~nonpartisan~~ political party designation or write-
10 in space for the office on the general election ballot. The name of the incumbent must be placed on the official
11 ballot for the general election as follows:

12 Shall (insert title of officer) (insert name of the incumbent officer) of the (insert title of the court) of the
13 state of Montana be retained in office for another term?

14 (2) Following the question, provision must be made, subject to rules adopted pursuant to 13-12-
15 202, for a voter to indicate a "yes" or "no" vote."

17 **Section 8.** Section 13-35-231, MCA, is amended to read:

18 **"13-35-231. Unlawful for political party to contribute to judicial candidate.** (1) A Except as
19 provided in subsection (2), a political party may not contribute to a judicial candidate.

20 (2) A political party may contribute to a judicial candidate who has advanced to the general
21 election."

23 NEW SECTION. Section 9. Codification instruction. [Section 1] is intended to be codified as an
24 integral part of Title 13, chapter 12, part 2, and the provisions of Title 13, chapter 12, part 2, apply to [section 1].

26 NEW SECTION. Section 10. {standard} Saving clause. [This act] does not affect rights and duties
27 that matured, penalties that were incurred, or proceedings that were begun before [the effective date of this
28 act].
