### Supervision

In Montana, nearly 1,800 offenders receive services daily to support their reintegration into the community and reduce recidivism.



### Treatment

90-day up to 270-day treatment options are available for direct placement for Alcohol, Substance Use, and Stimulant Use Disorders.



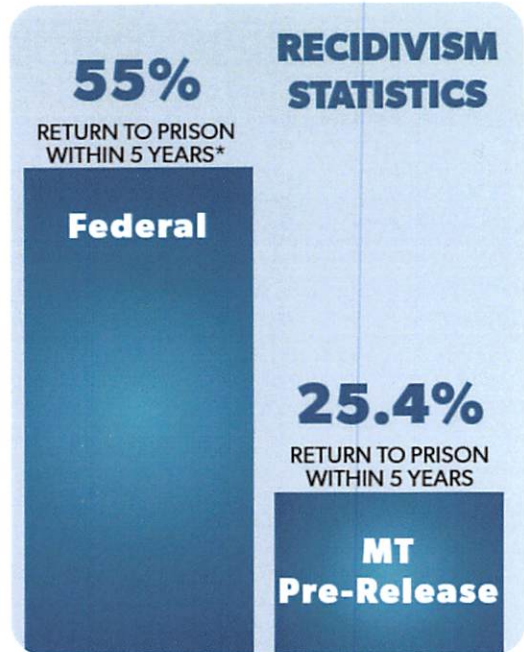
### Education

Offenders in MCCA programs receive education about their criminogenic risk factors, life skills, and Hi-Set or post-secondary education as appropriate.

MCCA facilities have operated for over 45 years, implementing cost-effective, evidence-based programming aimed at reducing recidivism, creating accountability for offenders, and working to reintegrate offenders back to responsible, productive, crime-free citizens.

There are 16 different treatment, supervision, and re-entry programs in MT that can receive inmate referrals through a DOC Commitment or a District Court Recommendation for 3-months, 6-months, or 9-months.
