^{*} SB74 from the 2025 Legislature changed the fee structure for Manufacturer licenses in 16-12-221, MCA. Fees are based on total concentrate production for each licensee (including all of their sites if they have multiple) rather than concentrate production per individual licensed site. The fees are now:

- \$5,000 for a manufacturer licensee that produces, on a monthly basis, less than 1 pound of concentrate and up to 10 pounds of concentrate;
- \$10,000 for a manufacturer licensee that produces, on a monthly basis, between 10 pounds of concentrate and 15 pounds of concentrate; and
- \$20,000 for a manufacturer licensee that produces, on a monthly basis, 15 pounds or more of concentrate.

Brief explanation of the table above:

- There are a total of 203 businesses with a dispensary license and 559 total licensed dispensary sites.
- Each distribution show how many licensees have that many dispensaries. 98 licensees have one dispensary, 39 licensees have two dispensaries (2 x 39 = total of 78 dispensaries), 23 licensees have 3 dispensaries (3 x 23 = total of 69 dispensaries), etc. The largest distribution count shows there is one licensee with 29 dispensary sites.
