- Replaced our outdated Panasonic system
 - Upload process slow
 - Servers maintained at each detachment failing
 - Discovery sometimes took hours
 - Equipment was failing
 - End of life for Panasonic software



- Added Body Worn Camera & Rear Camera
- Drastically decreased our time spent on discovery
- Increased our ability to access evidence quickly
- Improved clarity of video as well as POV when interacting with the public
