On behalf of the Attorney General, and pursuant to Mont. Code Ann. § 2-15-505 (2023), the Attorney General of the State of Montana respectfully notifies the Law and Justice Interim Committee and the Judicial Branch, Law Enforcement, and Justice Budget Committee that to the best of his knowledge, in fiscal year 2025, a mandatory minimum sentence was imposed in fentanyl cases as required by Mont. Code Ann. § 45-9-101(6) or § 45-9-103(3) a total of fourteen (14) times statewide. Notably, several counties were double-checking their records and may have additional data to report following the holiday weekend. Those counties include Lewis and Clark County, Sanders County, Lincoln County, Meagher County, Powell County, and Ravalli County. Accordingly, the Attorney General's Office respectfully advises that this number may increase after their responses are obtained. If additional data is obtained in the week following the Labor Day holiday weekend, the Attorney General's Office will provide a supplemental report.

This number is based on data reported by the County Attorneys across the state as directed by the Attorney General, as set forth in Mont. Code Ann. § 2-15-505. Please find included herewith two (2) pages that constitute the data supporting the total number, broken down by County.
