

## Table Summary: Buffer Zone Laws in Other States

### SUMMARY

A buffer zone law, or “Halo Law”, establishes a protective parameter around emergency personnel while they carry out their official duties. According to this law, an individual is prohibited from being within a certain distance of a first responder engaged in their lawful duties after receiving a verbal warning. A verbal warning is typically given when emergency personnel feel that a person intends to interfere with the first responder's official duties or is harassing or threatening the first responder with physical harm. Violators failing to comply with the verbal warning face a misdemeanor offense.

The table below summarizes recent legislation proposed in states seeking to establish buffer zone laws in their jurisdictions.
