RE: Working Group Representation and Parent Advocacy Groups in Montana

DATE: August 8, 2025

This memo is intended to remind members of the Commission about where things stand with representation for the Innovation and Excellence in Education Working Group (IEEWG), provide information about parent advocacy groups in Montana, and on behalf of Chairman Bedey and Vice-Chair Matthews, propose a path forward.

First, a refresher on what 5-20-301, MCA, (as amended by HB 153; emphasis added) requires of the Commission:

Under subsection (1)(d):

... for the commission formed during the 2025-2026 interim, **prior to conducting the study under subsection (1)(a)**, form an innovation and excellence in education working group to develop recommendations, objectives, and an implementation plan as described in subsection (10) to improve the basic system of free, quality, public elementary and secondary schools.

(This is why we have been referring to the IEEWG's work as "Phase I" of the Commission's work.)

Under subsection (10)(a):

The innovation and excellence in education working group is composed of the commission **and others as determined by the commission**. The commission **shall include representation** from teachers, school administrators, school trustees, and parent advocacy groups in forming the working group.

At the Commission's June 23, 2025, Zoom meeting, during discussion of <u>a memo on the IEEWG</u>, the Commission considered the following motion (as recorded in the <u>minutes log</u>):

Motion 13:34:21 Tom Burnett moved to invite a parent advocacy group member to work with the commission and rely only on commission members to represent teachers, administrators, business officers, and trustees.

There was discussion on the motion, then a roll call vote with the motion passing 13-7. Following subsequent public comment, Chair Bedey asked staff to compile a list of "parent advocacy groups" for the Commission's reference and consideration.

It was not clear from the June 23 meeting how the Commission intended to select a parent advocacy group and member of that group to work with the Commission. It was also not clear the number of parent advocacy groups that exist in Montana. The not-necessarily-comprehensive list included in this memo has 10 groups with various constituencies.

The Commission could proceed by selecting a parent advocacy group and asking that group to name an individual to join the working group, resulting in an IEEWG of 21 members, the 20-member Commission +1. Parent advocacy groups not selected and other stakeholder groups named in the statute might perceive that they are unrepresented.

The Commission communicated at its initial meeting a desire to robustly seek input from stakeholders throughout the IEEWG effort by incorporating outreach "roadshows", participating in the October educator conferences, and including opportunities for meaningful public comment at meetings.

An alternative to naming one individual from one parent advocacy group to formally have a "seat at the table" would be to name no additional members and instead rigorously encourage all the stakeholder groups to provide input through various means to ensure their "representation" and a "voice at the table". In addition to the already envisioned outreach efforts, this could include solicitation of written input, compiled, summarized, and presented to the Commission by the contracted IEEWG facilitator. Targeted input could be solicited at the outset, and again as the Commission develops its IEEWG recommendations and implementation plan.

This approach would satisfy the Commission's duty to "include representation" from the various stakeholder groups without incurring the cost of compensating additional member(s).
