Record of Decision Notices

Section 36 Plan • Business & Technology Park

August 11, 2001

The Department of Natural Resources and Conservation (DNRC) released a final Environmental Impact Statement (FEIS) on July 26, 2001. The FEIS is a two-decision document – identifying recommended alternatives for (1) a land use plan for School Trust lands located in Section 36, Township 29 N, Range 22 W, Flathead County, Montana and (2) a proposal by Hampstead Partners, Inc. to lease [from DNRC] approximately 60 acres in the aforementioned Section 36 to construct a business and technology park.

It is my final decision to select Modified Alternative D as the Section 36 Land Use Plan. Furthermore, it is my final decision to select Alternative B of the proposal to lease land for a business and technology park. Both of these final decisions and the reasons for these final decisions are the same as set forth in the FEIS, thereby satisfying the required items of Section 36.2.538 (1), Administrative Rules of Montana (ARM). The information contained in the FEIS is adopted by reference and the basis of information and reasons for the decisions are particularly described by the "Introduction" and "Part I" sections of the FEIS. This letter and the FEIS, together with a legal notice of my decisions, constitute a concise public record of decision, consistent with the requirements of Section 36.2.538, ARM. A notice of my decisions will be posted in the "Legal Notices" section of The Daily Inter Lake, a newspaper of local circulation, on August 11, 2001.
