Special Education Significant Needs Grant 2010 – 2019

Three Priority Levels:

Priority I – made available to schools who have <u>a student</u> whose excess costs for education exceed 5 percent of the district's general fund budget.

Priority IA – made available to schools experiencing a significant financial impact from the <u>start up</u>, <u>expansion</u>, <u>or increased school enrollment</u> from local <u>group homes</u> or new therapeutic foster care homes serving multiple students.

Priority II – made available to schools only after Priority 1 and Priority IA awards have been made according to the awards rubric. The rubric is a follows:

District Size: Less students, higher points

IDEA Carry-Over Funds: Less carry-over, higher points

IDEA Student in certain categories: significant behavior/physical needs, highest points (80)

IDEA Student in all other categories: lowest points (40)

Non-IDEA student in certain categories: severely emotional disturbed as determined by MT Mental Health, conduct disorder, or juvenile sex offender, highest points (80)

Non-IDEA student who did not fall into one of the preceding categories, but who has documented significant behavior needs: second highest points (50)

Districts are ranked from highest scores to lowest to determine funding.
