## **PSB Current Case Load**

PSB's primary mission is prosecuting criminal cases on behalf of counties that request assistance. Cases are referred to PSB when the case is too complex for the local county attorney to prosecute or when the county attorney has a conflict.

## **Homicide and Attempted Homicide Cases**

PSB is currently prosecuting 26 homicide/attempted homicide cases. PSB has carried approximately this number of homicide cases during the last couple of years. This number has increased dramatically since 2017.

## **Sexual Assault Cases**

PSB is currently prosecuting 28 sexual assault prosecutions. PSB has carried approximately this number of sexual assault prosecutions during the last couple of years.

## **Declination of Cases**

During the last several years, PSB has communicated with the Montana County Attorney Association that PSB does not have a lot of capacity to handle additional cases; however, that it is PSB's policy to accept homicide and sexual assault cases. PSB has advised county attorneys to rely on neighboring counties for assistance in cases that do not involve homicide or sexual assault.

Since tracking declination of county cases began in October 2023, PSB has formally declined 17 cases due to lack of resources. PSB believes that this number does not adequately reflect the counties need for PSB services because counties have been advised that due to resource limitations PSB is primarily accepting homicide and sexual assault cases.

## **PSB Other Duties**

PSB attorneys and staff also have a prominent role in training prosecutors and law enforcement throughout Montana. PSB attorneys interact with prosecutors daily to provide technical expertise. PSB also takes an active role in training law enforcement at the Montana Law Enforcement Academy. PSB members work with DOJ's executive team on various projects including drafting of proposed legislation. Most notably during the 2023 session was the revamping of the human trafficking laws. PSB is also in charge of sexual assault reporting and fentanyl reporting to the legislature.

Counties do not reimburse DOJ for the costs of PSB counsel or paralegals for their travel, which includes transportation, hotel, and per diem. Counties do pay the costs of all trial expenses including expert witness fees, witness travel, transcripts, and preparation of exhibits.
