With your permission, Mr. Chairman, I'd like to give you some background and my thoughts about conservation district current and future funding needs

I would like to begin my testimony with a brief review of Montana's 58 conservation districts. Conservation districts are a subdivision of Montana state government dating back to 1939. Each district has between 5 and 7 elected and or appointed, unpaid supervisors. The supervisors meet at least once a month at which time they administer the Montana Stream Bed and Bank act Preservation Law (aka 310 Law) and manage and implement conservation work in their districts. Conservation districts primary source of operating funds comes from a mill levy assessed against property in their district. The total amount of mill levy dollars derived from this assessment varies widely, with 42 of the 58 conservation districts receiving less than \$40,000 per year to hire and retain an administrator, conduct conservation work and pay their bills. Conservation districts implement conservation work in their districts that makes sense for their constituents. Conservation Districts are this state's natural resources wise use leaders

My testimony is divided into three distinct funding related needs.

First, we are concerned about funds available in the current fiscal year. We need funding to support conservation work in the next 6 months. CARD as well as conservation districts are facing a very significant shortfall in revenue as a result of declining coal tax revenues. This issue could be addressed in HB 3 and we are hoping for your support.

Second, I would like to speak to funding for CARD and conservation districts for the biennium beginning July 1, 2021. MACD supports the Governor's budget request for CARD and thus conservation districts. In addition, MACD requests that you consider an enhancement to this budget that will create a base budget for all Conservation districts of \$80,000 per year. The total estimated amount required to reach this base budget is \$2.7mm per year. I would like to draw you attention to the attached spread sheet which supports this request.

Third, I would like to speak to future funding for conservation districts. MACD requests that you consider the inclusion of an interim study in the appropriate legislation. The study would examine conservation districts and recommend the establishment of a conservation district trust fund, managed by the State of Montana. As part of the study, revenue streams to support the trust would be identified and the rules under which the trust would be managed and earnings distributed recommended.

SRWG is a 501c3 nonprofit organization headquartered in Great Falls. Our mission is to protect and restore the resources of the Sun River watershed and its communities. To support this mission, we implement projects that improve water quality and water management, control weeds, enhance habitat for fish and wildlife, restore hydrologic processes, and educate the public about our natural resources. We host events for volunteers and lead planning and on-the-ground projects. We also further our mission through work with local conservation districts, irrigation districts, government agencies, and other organizations.

SRWG is a small nonprofit, with one staff person and a board of directors. We could not accomplish the work we do to support local communities and natural resources without the good work of our partners like DNRC. Some of the important work SRWG relies on DNRC's Water Resources Division for includes:

- Support for seasonal stream gages
- Funding for the USGS stream gage at Muddy Creek
- · Grant funding and administration, especially the Watershed Management Grant
- Participation in the state-wide stream gage working group
- Providing advice and support to SRWG's Water Management Working Group
- · Administration of water rights across the Sun River watershed, for our residents and irrigation districts
- Facilitation of additional partnerships
- Education and training via the Montana Water Summit
- Advice and guidance for projects involving water management

I would like to provide two examples of the incredible value DNRC's Water Resources Division provides for SRWG:

In 2020, SRWG was unable to raise funding to keep a USGS stream gage operating on Muddy Creek. This gage has been in operation for over 80 years, one of the longest stream flow data sets in the state. The gage is important for flood forecasting, water management, and understanding the impacts of irrigation in this sub-watershed. The gage is also used by DNRC for administration of water rights. SRWG reached out to several partners to try and raise funding to keep the gage going. DNRC was able to help partially fund the gage and, because of their willingness to help fund it, another partner stepped up to fund the difference and keep the gage going. Without DNRC's financial support and Paul Azevedo's help reaching out to this other partner, the gage would not be operating today.

DNRC is also helping SRWG provide a valuable outreach tool for our community. SRWG had applied for funding to hire a consultant to build a River Conditions page for our website. This page will show real-time stream gage data,

Mister Chairman Homlund, Vice Chair Ankney, and Members of the Committee:

I am the District Administrator for the Lincoln Conservation District. Our Conservation District works diligently to protect and conserve natural resources in Lincoln County. Not only do we fulfill the state mandate to administer the 310 Law, but we also deliver educational programs to the public and facilitate conversations at the local level to foster better understanding of issues surrounding natural resources.

The Lincoln Conservation District is a proponent of House Bill 2. With a limited budget that stems from a county mill levy, we have utilized funding from the Montana DNRC to supplement our operating budget, deliver educational programs, and implement stream restoration projects.

Most recently, we relied on grant funding as well as technical expertise to complete a one-mile stream restoration project on the Tobacco River. With DNRC's assistance, we were able to enhance habitat conditions in an important reach of the Tobacco River that serves as a critical migratory corridor to spawning and rearing tributaries in the Upper Tobacco River drainage. Similarly, we were able to restore stream health on Mud Creek which was once an old mill site. These projects would not have been possible without the staff and funding from DNRC. We also rely heavily on this agency for technical assistance in administering the 310 Law.

Mr. Chairman, Mr. Vice-Chairman, and Honorable Members of the Committee:

As Coordinator for the Milk River Watershed Alliance (MRWA), I am tasked with promoting the preservation and rehabilitation of the Milk River Project. To accomplish this task, I work very closely with and represent the Conservation Districts that share the Milk River: Glacier, Hill, Blaine, Phillips, and Valley. Because of the rural nature of the communities along the Hi-Line, the Conservation Districts struggle to fund the most essential services they are required by law to provide.

Thankfully, the Conservation and Resource Development Division (CARDD) has continually offered financial stability for each of these districts. Should CARDD funding be reduced, in even the slightest of margins, rural Conservation Districts' ability to operate would be fundamentally challenged. Even with CARDD grants and programs, many of these districts struggle. I would like to express MRWA's support for the budget proposal before you. Additionally, MRWA supports the proposal for an enhanced base budget for all conservation districts in the amount of \$80,000 annually. Montana is recognized worldwide for its commitment to conservation and natural resource preservation; imagine the potential of these districts if they have the funding to sustain their existing programs, and expand conservation efforts within their jurisdiction.

Not only does CARDD support each and every Conservation District in the state, they also support countless conservation-focused organizations such as MRWA. In 2017, MRWA received a \$50,000 Technical Assistance Grant to fund administrative and operating expenses. In 2020, an additional grant in the amount of \$30,000 was awarded to continue the financial support of MRWA. With this funding, MRWA has been able to hire a full-time coordinator to build partnerships, collaborate with government agencies and NGOs, and educate the public on the issues that face the Milk River Watershed. CARDD is crucial to the operations of MRWA.

On behalf of the Milk River Watershed Alliance, I would like to ask this Committee to approve the proposed funding for the Department of Natural Resources and Conservation, Conservation and Resource Development Division, and ask for the consideration of an enhanced budget during this legislative session.
