# Architecture and Engineering Study

- ☐ Conducted by DOA Architecture & Engineering Division staff. Stakeholder survey comments were also taken into consideration.
- ☐ Began in October with meetings with Academy staff to discuss infrastructure and training requirements.

☐Goal was to create a prioritized LRBP template.





#### **Problems Continue**









# Architecture and Engineering Study

- A & E and Academy staff were sensitive to the structural (mostly exterior)upgrades that have been made over the years. Repurposing existing buildings and finishing what was started became the theme.
- One exception was the Cottonwood dorm building. No improvements have been made, foundation continues to settle.





### Architecture and Engineering Study

- Top 3 priorities identified were;
- Complete dorm improvements (HVAC),add dorm rooms to Maple, Aspen, Spruce and Clinic buildings to total 106 beds \$5,023,470.00
- Improve cafeteria capacity \$1,431,730.00
- Build a 10,200 SQ FT indoor training facility on site to accommodate outdoor training in in-climate weather.\$3,241,709.00





### Architecture and Engineering Study

- Addition of 12 offices to Ohs Building. This would create efficiency in locating MLEA and POST staff in one building. \$594,063.00
- Return Administration Building main floor to classrooms. This would allow for increased training capacity on campus.\$1,619,408.00
- Increase maintenance shop capacity to accommodate vehicle repairs.\$370,673.00



### Architecture and Engineering Study

- Cottonwood dormitory demolition. The foundation continues to settle causing cracking in many of the cinder block walls.
  Other than plumbing upgrades, no money has been spent structurally. \$314,004.00
- New dormitory building TBD
- Total cost of master plan \$12,595,057.00



# Architecture and Engineering Study

- DOJ recommendations fund all phases at once and in their entirety.
- All phases support HJ008 directives in reviewing current and future campus needs.
- Improvements would meet current and future life support and training needs for students.





#### **Funding Around The Country**

- Academy's in other states were asked how they are funded.
- Kansas, Michigan, Oklahoma and Nebraska collect surcharge revenues. All report it is insufficient to meet needs.
- Vermont was special revenue until 2010, funds not reliable and now general funded.





#### **Funding Around The Country**

- Kentucky 1.8% surcharge on at risk insurance policies (homes, businesses etc.).
  Revenue collected is shared with firefighters.
- Ohio 2% casino tax.
- New Mexico 10% of all money received from fees, licenses, penalties, and taxes from life, general casualty and title insurance businesses.



#### **Funding Around The Country**

- 18 responded, of those 8 are fully or partially funded by general fund revenue.
- 5 agencies reported revenue shortfalls.
- Common theme is special revenue instability.





#### **Revenue Growth Opportunities**

- On-line learning
- Increased professional programs
- Increased class sizes (linked to increased staffing and room availability)
- Conferences
- Increasing customer base;
  - Federal agencies (U.S. Forest Service)
  - Other state agencies
