### **Regional Reports of Maintenance Completed through August 15, 2010:**

The acquisition of Fish Creek State Park closed on June 17, 2010. State Parks committed \$7,500 of FY2010 base operations for the control of weeds at the park.

### **Maintenance Plans for FY11:**

Operations of \$10,000 are earmarked for weed control at Fish Creek State Park. The balance of the fund will be used to address maintenance issues as needed at the site over time.

**Maintenance Plans for FY11:**

The Ranger in Region 3 will continue to maintain the Beaverhead and Big Hole River FAS while also improving landowner relations and overall management. This position is currently budgeted for \$60,340 in personal services and operations.

Maintenance of FAS's is an ongoing challenge directly helped by SB 164. In some locations, such as the Beaverhead and Big Hole rivers, the challenge is magnified by lack of staff to work locally. Since 2000, the Beaverhead and Big Hole rivers were being managed out of Bozeman. Now SB 164 funds are being used to have a ranger work out of Dillon to improve site maintenance, landowner relations, and overall management of the land.

In a 2009 weed audit, weed control at FASs was identified as a problem. A key concern of field staff is the lack of hired help to address needs. Weed control and coordination is being done at the same time as bathrooms need cleaning, fences mended, construction is occurring, and visitors are using sites.

The division has requested approval to put 6 half-time maintenance workers on the ground around the state to deal with weed control and improve coordination with counties and landowners while also providing maintenance support for other tasks like fence repair and litter pickup. Operation monies will go toward weed contracts, chemical and biological control, and other direct expenses. See table 2 below.

- In FY10, FWP utilized a limited amount of resources from the WMA Maintenance Fund as most of the scheduled maintenance was already programmed and budgeted within existing budgets.

### **Regional Reports of Maintenance Completed through August 15, 2010:**

Resources from the WMA Maintenance Fund were used to create/pay for FTE in Regions 1, 2, and 6 as follows to assist with WMA maintenance, especially new projects:

- R1 - .25 FTE - to assist with maintenance on the recently acquired North Shore property, as well as Nine Pipes WMA parcels.
- R2 - .35 FTE - to assist with maintenance of R2 WMAs including the recently acquired Little Doney WMA, Stuckey Ridge portion of Blue Eyed Nellie WMA, and others.
- R6 - .50 FTE - to assist with maintenance on the newly acquired Cree Crossing WMA, as well as other R6 WMAs including Fresno Reservoir WMA, Fresno Tailwater WMA, Hinsdale WMA, Milk River WMA, and Rookery WMA.

### **Maintenance Plans for FY11:**

R1 – WMAs in the Mission Valley and the Flathead Valley -- Utilize FTE created in FY10 (0.25 FTE) to address weed issues.

- Salary - \$7,000
- Operations - \$10,000 (weed chemical, equipment, and fuel)

R2 – Fish Creek and Marshall Block -- In addition to the ongoing FTE/maintenance described above, significant start-up maintenance needs are anticipated. Needs include:

- Four 6-month positions (2 FTE) -- \$50,000
- weed control, signage, road maintenance, parking lot construction, and gates -- \$80,000

R2 - Three Mile WMA -- The entrance road is in desperate need of repair to reduce sediment input into the stream. This project is in cooperation with with the County and USFS as they improve their adjacent road sections.

- Road work -- \$100,000

R2 – Three-Mile WMA

- Weed spraying -- \$4,200

R2 – Blackfoot-Clearwater WMA

- Aerial weed spraying -- \$7,000

R4 - Judith River WMA -- The primary hunting access to the Judith River WMA on the north side is Rogers' (neighbor) access road.

- Road improvements on both private land and FWP land -- \$20,000

R4 - Judith River WMA -- Investigate water development on the south portion of the WMA, adjacent to USFS and private property. Redistribute cattle in the existing grazing program or expand grazing to utilize cattle for vegetation treatments south of the county road.

- Water development -- \$12,000

R4 - Marias River WMA --Aerial treatment of additional acres (340 acres treated in 2010) for control of leafy spurge, Russian and Spotted knapweeds, and whitetop and pepperweed infestations to reduce weed encroachment on adjacent private land.

- Weed control -- \$12,000

R4 - Marias River WMA -- Road improvements on the Clark access route.

- Road work -- \$15,000

R4 – Marias River WMA

- Boundary fencing and road maintenance – 80,000

R4 - Beckman WMA -- Move the existing irrigation pump site for the center wheel line system so the farming lessee (neighbor) will be able to protect the pump site that is in a location of severe bank erosion.

- Relocate irrigation pump -- \$5,000

R4 - Beckman WMA -- Identify and improve an access route from the Bear Springs County Road (N boundary of WMA) through the Thompson property (we own an access easement) to the northern corner of the Beckman WMA .

- Access road -- \$12,000

R6 WMAs – Provide a half-time position and operations for weed control efforts.

- Salary for 0.50 FTE Tech - \$19,000

- Operations, primarily weed control chemicals -- \$2,500

**Additional Information:**

Wildlife expended a significant amount of operations funds on WMA maintenance throughout the state in FY10 using funds earmarked through Habitat Montana per 87-1-242. These funds were used as follows to meet the intent of the Good Neighbor policy. FY11 expenditures and activities will be similar.
