HJR 46: Study of Election Laws Explanation of LC 60 – Mail Ballot Pilot Project

April 2008

The initial draft of LC 60primarily includes elements approved at the Feb. 22, 2008, meeting of the State Administration and Veterans' Affairs Interim Committee. However, it also contains provisions that recognize concerns raised by county clerks and recorders who indicated an interest in taking part in the pilot project. Issues involving the use of accessible voting machines are more fully discussed in a separate briefing paper entitled "HJR 46: Study of Election Laws – Use of AutoMARK Machines."

The following table summarizes the elements of LC 60 and the policy items to be decided by SAVA before a final bill draft is prepared.
