### 58th Legislature - Projected Session Calendar

<u>Please note:</u> This calendar is subject to change. By law, the session convenes on Monday, January 6. However, legislative leadership has the authority to revise the schedule once the session begins.

**Introduction deadlines**: Generally, bills and resolutions must be introduced within 2 legislative days after delivery. JR 40-50. However, House rules provide for introduction within 48 hours from the time that the bill was accepted from the Legislative Services Division and provide that "[n]o bill or resolution may be introduced any later than 5 p.m. 5 legislative days prior to the appropriate transmittal deadline." H40-10.

"General bills" is used to denote all bills, except appropriation or revenue bills, and all joint resolutions.

**Notes**: This schedule is based on the Joint Rules adopted by the 57th Legislature. Deadline dates are determined according to legislative days, using a 6-day legislative week. The Legislature will meet on Martin Luther King Jr. Day and Presidents' Day, which are otherwise state holidays. The beginning and ending of breaks, such as at transmittal and Easter are solely the discretion of the Senate and House and may be changed without notice.

Certain bills and resolutions relating to administrative rules may be transmitted at any time during the session. JR 40-200(3).
