CONFERENCE COMMITTEE ACTION ON HB 420

Senator Keating called the meeting to order and explained the
Senate's amendments regarding changing the date from 12/31/98 to
12/31/99 in their amendments.

Russ Ritter from **MRI** then informed the committee that if the
committee would restore the date back to 12/31/98-**MRI** through
negotiations with Butte Silverbow Counties and School Districts,

MRI would reimburse by private contract to the county roughly \$60,000.

Discussion: Rep. **Gillan** did inquire of the committee the fiscal impact this would have regarding reimbursement schemes as to the Dept. of Revenue's plan. **Mr. Ritter** stated he had spoken with Mary Bryson from the Dept. of Rev. and this would not a part of the reimbursement plan from the State. **Sen Keating** remarked for the record:"the price of copper is at such a low level, that this operation is marginal at this point, that if they stop operating then the county and the state and the school districts get nothing if there isn't any production, we have to keep that in mind when we're dealing with this".
