

1999 Committee Minutes are named by date of the hearing plus the committee code.

For example, 981123JOH\_Hm1.pdf; the first 2 digits represents the year [1998], the next 2 digits represents the month [11; i.e., November], and the last 2 digits is the day of the month [23]. The next 3 characters represent the committee code, in this example, "JOH".

Looking at the code to committee cross-reference below, you can see JOH is the code for the House Joint Select Committee on Jobs and Income.

Minutes for Conference Committees and Free Conference Committees also include the bill number in the file name. For example, 990326SB0243CCS\_Sm1.pdf is the minutes for the Conference Committee hearing on SB0243 which took place on March 26, 1999.
