Discussion:

SEN. KEENAN asked about procedures regarding the Governor's amendments.

CHAIRMAN COONEY allowed public testimony, and directing questions to **Jon Moe, Legislative Staffer**.

Mr. Greg Petesch, Code Commissioner, was called to clarify the Governor's amendments which were rejected on the House floor on 4/19/2005. The new amendment, **SB012001.asb** was the agreed upon language. The Governor's amendments, therefore, were not applicable to the bill.

SEN. KEENAN said you could cut through the bill language to the key words which were: "collection of the utilization fee", and, "must cease if the court issues the final order and the state expenditure limit has been exceeded". He was concerned about what would happen in December 2005 since the CAP is a biennial budget issue and not just applicable to this session.

Mr. Greg Petesch entered the committee room.

SEN. COONEY explained that the CAP tends to change on a regular basis. There will be new numbers coming in from the Department of Labor in about three months. The CAP will be volatile throughout the biennium and is a "moving target" because of shifts in federal numbers.

CHAIRMAN COONEY asked **Mr. Petesch** to clarify the previous questions about the Governor's amendments to which he replied, "The Governor's amendments are never on the bill until both houses accept them, which is why you don't vote on them on third reading also".
